To make sure you have access to the highest quality women's health care during this transition and into the future, on Dec. 15, AAMG Women's Collaborative Care will open in the same office space where AAMG Pavilion OB-GYN is currently located, on the third floor of the Belcher Pavilion, Suite 309. Dr. Coryse Brathwaite, Dr. Janifer Tropez-Martin, Dr. Rhoda Raji, Dr. Jana Kaplan, and Sara Shaffer, CNM, will provide obstetric and gynecologic services. Additionally, an AAMG fellowship trained minimally invasive gynecologic surgeon, Dr. Jessica Ton will also be seeing patients in this office. Appointments may be made with Dr. Ton by calling 443-481-3493

In order to ensure a seamless transition, and with your consent, these providers will have access to your medical records. AAMG also has other providers and offices located throughout the community that are accepting new patient. If you need me to re-fill a prescription, please request it from my practice by December 5. If you have orders for laboratory tests or imaging studies such as ultrasounds or mammograms, please complete them by December 2 so that I will have time to review your results before I leave.
